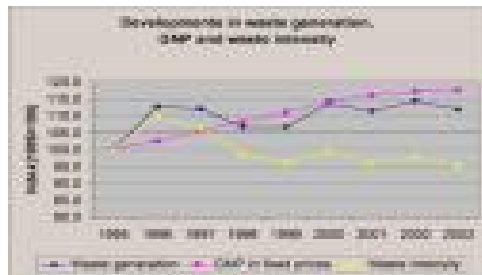

PCBs	1000	100%

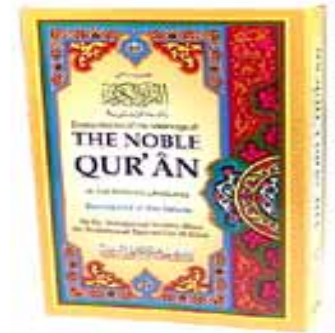
